

## COMPETITION TERMS AND CONDITIONS

The Promoter – The promoter is Redgrange Limited a company registered in Ireland under No. 197260 with its registered office at 169 the Village Centre, Killester Dublin 3. Eligibility Criteria – This competition (“Competition”) is open to persons who are aged 18 years or over and are residents of the Republic of Ireland. All employees or agents of the Promoter and their families are excluded.

How to Enter – Eligible Persons may enter by:

Proof of submitting an entry is not proof that the entry has been received by the Promoter.

Terms of Participation – Entrants are deemed to have accepted these terms and conditions by confirming their wish to participate in the Competition.
